BYLAW NO. 2018-11 A BYLAW OF THE TOWN OF BON ACCORD TO AMEND LAND USE BYLAW 2016-03 OF THE TOWN OF BON ACCORD

WHEREAS the <u>Municipal Government Act</u>, R.S.A. 2000, as amended ("the Act") provides that a Municipal Council may amend its Land Use Bylaw;

AND WHEREAS the Council of the Town of Bon Accord wishes to amend its Land Use Bylaw as it affects certain lands;

AND WHEREAS the lands legally described as

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION EIGHTEEN (18), TOWNSHIP FIFTY-SIX (56), RANGE TWENTY-THREE (23), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BON ACCORD.

THE NORTHEAST QUARTER OF SECTION THIRTEEN (13), TOWNSHIP FIFTY-SIX (56), RANGE TWENTY-FOUR (24), WEST OF THE FOURTH (4) MERIDIAN.

ALL THAT PORTION OF THE SOUTHEAST QUARTER OF SECTION THIRTEEN (13), TOWNSHIP FIFTY-SIX (56), RANGE TWENTY-FOUR (24), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BON ACCORD LYING NORTH OF THE PROJECTION WEST OF THE SOUTH-WEST POINT OF PLAN 772-2401.

(the "Lands) were annexed to the Town of Bon Accord from Sturgeon County effective April 1, 2018;

AND WHEREAS in accordance with s. 135(1)(d) of the <u>Municipal Government Act</u>, R.S.A. 2000, c. M-26, as amended, the Land Use Bylaw of Sturgeon County continues to apply to the Lands until the Town amends the Town of Bon Accord Land Use Bylaw 2016-03 to specifically deal with the Lands;

AND WHEREAS the Council of the Town of Bon Accord wishes to have the Town of Bon Accord Land Use Bylaw 2016-03 apply to the Lands;

NOW THEREFORE the Council of the Town of Bon Accord, duly assembled, enacts as follows.

- 1. The Land Use District Map is hereby amended by redistricting the following lands, which are currently within the AG: Agriculture General District, within the Sturgeon County Land Use Bylaw 1385-17, as amended, to UR Urban Reserve District in the Town of Bon Accord Land Use Bylaw 2016-03:
 - a. Pt. NW 18-56-23-W4;
 - b. NE 13-56-24-W4;
 - c. Pt. SE 13-56-24-W4;
 - d. Plan 8322285;

- e. Block A, Plan 4563KS;
- 2. The affected areas described above are shown on the attached Schedule A, which is attached to and forms part of this bylaw.
- 3. This Bylaw comes into full force and takes effect on the date of third and final reading.


