- ☐ 4 I/We understand that payments are to be withdrawn on the 15th of each month.
- ☐ 5 I/We understand that if a payment fails to be honoured, a service charge (according to the Fees for Service Delivery Bylaw, Corporate Services Fees) approved by Resolution #23-176, will be added to my/our property tax account, and any applicable penalties will be charged.
- ☐ 6 I/We understand that if a payment fails to be honoured prior to the next installment date, it may result in the account being removed from the program.
- ☐ 7 I/We understand that payments made in addition to the pre-authorized withdrawals will not effect the withdrawal amount and adjustments will not be made based when these payments are made.
- ☐ 8 I/We understand that this authorization is subject to change to reflect the current annual Property Tax Notice issued by the Town of Bon Accord.
