COMMUNITY SERVICES

Mental Health First Aid

I will be receiving my Mental Health First Aid certificate in the next few weeks. The course was very informative and will benefit my role as Community Services Coordinator.

Pickleball

Pickleball has been running for 5 weeks; the attendance has been steady in numbers. There is an average of 5 participants, majority from Gibbons. Program did not run on February 11, due to school event and Family Day February 18.

Primary Care Network (PCN) sessions

The first of many St. Albert PCN workshop was held on January 21. There were 4 participants, which allowed for a more intimate class with great conversation. The next workshop is on February 21 Retirement- Retire from work, not life is running on February 21. We currently have 7 registered for this session.

We will host another workshop on March 18, this session is on Grief & Loss. These are free sessions offered from PCN and supported through FCSS. The sessions will be held in Council Chambers from 6:30 - 8:00 pm. These sessions are being advertised on our Facebook page, website, Newsletter, E-newsletter, poster at a few locations and on the Community event sign.

Family Day

This event took place on February 18 and we had approx. 70 people in attendance (down from 80 last year). The event cost roughly \$325 for the supplies, hot dog lunch, and door prize. Donations for the Food Bank consisted of \$20 in cash and several bags of food. Surveys that were filled out by the families indicated that they thoroughly enjoyed their time and felt closer to their families. Out of the 13 surveys completed: 9 families heard about the event on the Facebook page, 1 website, 1 flyers around town, and 2 word of mouth. Only suggestion made was to send out tickets or invites to the schools for each child, this comment will be taken into consideration for 2020.

Spring program guides have been finalized; they are scheduled to be mailed out with the February Utility bill in the beginning of March.

Outcomes Measures Feb. 22 – 23

Recording and reporting program Outcome measures are required for FCSS Provincial funding. This 2-day training provided information on new outcomes, measures, and formatting that will help streamline the reporting process.

Summer Camp meeting

Preliminary discussions with Gibbons Recreational department took place on January 31. Discussions on possible collaborations and to see if joint field trips would continue this year.

ICS 200 Training

I attended a 2-day training in Redwater, and I am now ICS 200 certified. I hope to obtain ICS 300 by the end of 2019.

Medically At-Risk Drivers (MARD)/Sturgeon Region Collaboration Meeting Feb. 6

A member from the Wainwright Medically At-risk transportation board presented to our group. He discussed how their program has been running for 5+ years, how it has been supported by the Council of Wainwright, Corporations and individuals. Most of the funding comes from donations, grants, and sponsorships. Their paid driver service offers individual and group trips to surrounding areas and larger centers such as Edmonton, Camrose and Calgary.

PLANNING & ECONOMIC DEVELOPMENT FEBRUARY 2019

ECONOMIC DEVELOPMENT

MLA Sarah Hoffman – Minister of Health

Met with Minister Hoffman to discuss the lack of Doctors in Rural Alberta. The exchange of information did not advance our position. Minister Hoffman mentioned there are 400 nurse practioners working in the Province providing excellent care. Currently there are pilot projects in Slave Lake, Wabasca and SAGE (downtown Edmonton) in which nurse practioners are utilized for full health care services.

Councilor Bidney, CAO Pierce and I will be pursuing other avenues with a direct approach to Regional Hospitals and existing Doctors.

Urban Developers Institute (UDI)

ATB Financial Chief Economist Todd Hirsch was the guest speaker at the UDI Luncheon January 11/19, presenting 2019 Economic Outlook. Todd focused on five key trends that will affect 2019 and coming years: *Trans-Mountain Pipeline*

The pipeline is the number one issue facing the province. He noted the Federal Government asked for 22 weeks last September to meet the requirements of the National Energy Board regarding construction, putting the decision deadline at the end of March, which will be one the most important economic landmarks of 2019. Todd also eluded to other alternatives for transportation of oil rather than the pipeline, including turning bitumen into pucks – innovative thinking.

Economic Diversity

From a policy perspective this has always bedeviled all different levels and orders of Government, Federal, Provincial and Municipal. Diversity happens organically, need to get out of old-fashioned ways of thinking about energy and agriculture. Energy involves far more than hydrocarbons such as renewable, geothermal energy's, wind and solar, etc. Agriculture is not just wheat, beef and canola, there is more opportunity in specialty crops such as cannabis, organic crops and all the food and beverage processing around that.

Artificial Intelligence and the Future

Artificial intelligence and the future of the workforce not only affects Alberta, but every country, industry and person. No one is immune to the forces of technology, artificial intelligence, robotics and automation such as the transition of full-serve to self-serve gas stations in Canada. The rate of change can be alarming, however if we remain flexible in our workforce, this will give workers the best opportunities to find those jobs and those new sectors which will emerge.

Disparity in Wages, Income and Opportunities

Disparity in wage, income and opportunity is often seen as social issue, however it is both social and economic with a greater disparity among young people over time. It is a social problem that will give rise to discord and



discontentment, which translates into economic problems and challenges. Todd does not have a solution to deal with income disparity other than civil engagement. Need to start communicating about ways to promote equity with other income opportunities. It is time Albertan's start a conversation around how we deal with this growing gap between those who have and those that do not have.

Global Economy

The direction of the global economy will directly affect Alberta in 2019. The disappearance of the neoliberalism, encouragement of free trade and the trend of countries moving insular will affect Canada and Alberta in the years to come. Canada is very export, very globally orientated. If the world does not tend to move more into anti-trade positions, it will impact activity in Canada. Unfortunately, this is something that Alberta and Canada do not have control over.

Rural Health Professions Action Plan (RhPAP)

Communicated to Kim Flemming (Rural Community Consultant) action steps the Town has taken to date. The Town has been in contact with the Primary Care Network and have attended resident recruitment sessions with the U of A and Rural Alberta Red Deer. Other connections that may be helpful to pursue would be Redwater Hospital (Site Manager), Alberta Medical Association, Dr. jobs website, and the Alberta Medical Association.

Veterans Service Centre – 12325-97th Street NW, Edmonton

Through this project, the Government of Alberta brings together existing service providers in one convenient location to make it easier for veterans to get the support they need, when and where they need it. Staff and peer-volunteers are onsite at the service center to provide a wide range of support and services:

Edmonton Global

Edmonton Global has hired new personnel to complement the team: Lynette Tremblay (Vice Pres. Strategy & Innovation), Chris McLeod (Director, Marketing & Communications), Perry Eddy (Manager, Business Development), Thomas Nilsson (Director, Research & Market Intelligence), and Karra-Lee Gerrits (Director, Business Development).



A presentation was provided by Conway and Incite for the Phase II, In-Market Positioning (reference attachment) regarding key items to address and timelines for key deliverables. Majority of deliverables will be completed prior to the Annual AGM for all regional shareholders, April 11/19.

PLANNING AND DEVELOPMENT

Safety Codes Council

Safety Codes Council initiated an audit of Sturgeon County, Bon Accord, Gibbons, Legal and Redwater regarding code systems of the building, electrical, plumbing, and gas disciplines on January 21 and 24/19. Random permit files were selected for both open and closed files for auditors to review. Overall findings discussed at the Audit Exit Meeting were positive with recommendations to add more detailed notes in the permits as per service provider. Inspections Group is the Towns service provider for Building Permits. The Town is a partner in the regional Quality Management Plan, including Sturgeon County, Gibbons, Legal and Redwater. The QMP Manager is a representative from Sturgeon County.

Town of Bruderheim

A Strathcona County-based Canadian Rockies Hemp company will be locating an industrial hemp production facility in Bruderheim. Situated before the town between the CP and CN tracks on 75 acres of agriculture land, the hemp fiber decorticator plant will see area farmers grow hemp set at a certain price per pound which would then be processed, and based on the length of grain, it could be used in textiles or manufacturing of fiberglass, car panels, insulation products and plane parts. The facility will process three hemp products: fiber, hurds and biomass. The company expects to break ground in the Spring, with construction taking 3-4 months for completion and operational by August 2019.

The Grey Market

With indications that many older Canadians have become interested in medical cannabis product, Canadian licensed producers such as CanniMed, a division of Aurora Cannabis have been focused on supporting patients older than 55 along their medical journey. Statistics Canada reports that several Canadians aged 65 and older has climbed to nearly 17 per cent of the population. That number could climb as high as one in four by 2031. At the same time in both Canada and the USA indicate that use of cannabis is increasing sharply among baby boomers.

As the senior demographic in Canada continues to grow, licensed producers must stand with older Canadians to ensure that medical cannabis is used to optimize treatments considering a growing base of medical research, while providing them with the support and education required to devise effect treatment plans.























Approach for Phase II – Key Items to Address







Why artificial intelligence matters

Machine Learning 101 (or Why a Mayor should care about ML)

"I have a hard time thinking of an industry that I don't think AI will transform in the next several years" – Andrew Ng, founder Deeplearning.Ai

AI – artificial intelligence – Replicating part, all, or more than human intelligence Machine Learning – Enabling computers to learn without being explicitly programmed (usually with large datasets)

Deep Learning – Building multiple layer of abstraction on datasets to construct higher-level meaning

Moore's Law:

Computer power/\$ increases exponentially, with a doubling time of 18-24 months (5 years = 10x)

This trend has held for at least 60 years and will continue for the foreseeable future. The Albertan Edge

"The AI community in Edmonton may have gotten off to a quite start, but it is now viewed as a world leader in the field" – a quote from the Financial Post 2017 – Google's Deepmind opens in Edmonton

Example:

Deepmind cut energy used for cooling by 40% at Google's data centers. COIN (Contract Intelligence) Program Saved JPMorganChase 360,000 hours of work annually and reduced mistakes in 12000 contracts

Flint, Michigan used AI to determine if pipes should be dug up

Board Highlights — January 2019

Alberta Environment and Parks—Water Management Framework

Mike Darbyshire gave a presentation on the status of the Province's Water Management Framework for the North Saskatchewan River and what it means to the ACRWC. In summary:

- The ACRWC will continue to work with Alberta Environment, EPCOR and Industry to identify the impact of its effluent loading on North Saskatchewan River and will need to budget extra costs in 2020 for additional monitoring.
- The outcome of the framework in terms of loading allocation will be reflected in future operating approvals issued by the Province.
- Possible management actions for contaminants of concern could include source control measures and/or may require higher levels of treatment.
- Meeting higher limits on effluent quality will require capital investment and will have an impact on the rate charged to members.

Asset Management Policy

The Board adopted an updated Asset Management Policy that better reflects the requirements of an effective asset management program and will be the foundation for the development of all other aspects of the program.
