ECONOMIC DEVELOPMENT

Brownlee – Emerging Trends in Municipal Law

Brownlee LLP hosts an exclusive legal education seminar for Municipal elected officials and employees each year. This year's topics included: economic development, revenue strategies, employment restructuring and value procurement. Sessions were valuable and informative, very timely regarding the Towns proposed development strategy.

Greater Edmonton Economic Development Team (GEEDT)

The committee is currently reviewing the terms of reference to articulate the purpose of this committee. With the formation of Edmonton Global, GEEDT will support the initiatives of Edmonton Global, acting as an additional conduit for the region. To note Leduc-Nisku EDA will be dissolving by the end June.

Edmonton Economic Development Corporation (EEDC) will no longer focus on some of the International Business. This will be funneled through Edmonton Global. For clarity, Edmonton Economic Development Corporation is a not-for-profit company established by the City of Edmonton and is responsible for economic development initiatives that generate economic impact building the reputation of the City.

Sturgeon County

Canada Kuwait Petrochemical Corporation (CKPC) has officially announced it will build a \$4.5 billion (gross) petrochemical complex as a 50/50 joint venture between Canadas Pembina Pipeline Corporation and Kuwait's Petrochemical Industries Company K.S. C (PIC) in Sturgeon County.

This investment will help support Alberta's Industrial Heartland as an economic driver which boasts more than \$40 billion in current capital investment, which translates to over 6,000 direct and 25,000 indirect jobs (*reference attachment*).

Alberta Industrial Heartland Association

PLANNING AND DEVELOPMENT

<u>Chestermere – Tax Breaks</u>

The City of Chestermere is a population of 20,000 and is introducing a big tax break to encourage economic development. The City will offer a tax reduction for new building construction, with occupancy taking place within two years of receiving permit (*reference attachment*).

Edmonton Housing Research Corporation (EHRC)

EHRC provides a semi-annual on Multi-Family dwellings across the region. This report provides extensive results of new multi-family projects currently marketed in the Edmonton area (*reference attachment*).

Canadian Home Builders Association (CHBA)

CHBA is a not-for-profit association that represents industry to governments of all levels, as well as collaborating with other local, provincial and national associations to ensure consistent approaches when addressing industry issues and challenges. CHBA is an advocate for new home builders, renovators, land developers, trade contractors, product and material manufacturers, building product suppliers, lending institutions, insurance providers, service professionals and other affiliated organizations. - Familiarize Members with the ICS Planning Process
- Carry out all Stages of the ICS Planning P
- Collective Training with Regional Peers

This was the first functional exercise for this partnership and was attended by members of AHS, AEMA, NAIT EM program volunteers, St Albert, Strathcona IMT all acting as mentors or observers. The exercise was built to practice the following skills and drills.

The exercise was functional in type. This practiced participants into conducting a formalized planning cycle for a plausible emergency scenario utilizing the Incident Command System (ICS).

The intent of this training was to focus on issues that exceed the scope of tactical emergency services guidelines and require additional coordination, planning and administrative support.

Municipal staff from 5 of the 6 SREMP Member communities participated in pre-identified functions as per ICS (i.e. Command, Liaison, Safety, Information, Operations, Logistics, Planning,

Finance/Admin). The majority of staff involved in the exercise already possessed a baseline level of training in their function.

This exercise served as a test-run, in accordance with the plan to comply with the new Local Authorities Emergency Management Regulation (LEMR). The target for SREMP was to exceed the standard set out in the LEMR by executing a regional functional exercise annually.

The aim of the exercise was met and an AAR is being produced by all involved and will be distributed to all of the 6 municipalities in the SREMP.

Well done to SREMP for exceeding the standard and a job well done!
