ECONOMIC DEVELOPMENT

Sturgeon County Mayor's Golf Tournament

This year Bon Accord will be an exclusive "Passport Sponsor" at \$500. This package includes exclusive recognition on the Golf Passport including special contest entries, mulligans and more. This is available to all golfers for tournament play.

Redwater Golf Tournament

The Town of Redwater will be hosting their open tournament Thursday, June 13/19. Details on registration will follow closer to date. Economic Development Alberta (EDA)

Economic Development Alberta is Alberta's leading economic development network. As a non-profit organization they are governed by a volunteer board of directors that represent the interests of membership.

Economic Development Alberta hosted their annual conference in Banff April 2-5/19. Conference sessions were informative and engaging with a focus on:

 - Not aggressively supporting current companies / businesses
 - Being boring (need to evolve, adapt, adjust)

Council / Administration Briefing



Preliminary discussion regarding development opportunities of Town owned land was insightful and positive. Lands in particular are the Town owned land across from the Town Office and what type of development may be considered. Public engagement will be vital to understand the needs of residents.

Edmonton Global

With the Town being a shareholder of Edmonton Global, it is valuable to understand what services/benefits the organization is providing to its shareholders:

- Edmonton Global has been working with Global Affairs and Invest in Canada on a program for a "Team Canada" approach to the "Collision Conference" which is a massive event taking place in Canada for the 1st time. The Canada program will include a large pavilion with a stage, meeting space and private rooms for meetings under a Canadian banner. There are about 9 Canadian cities participating including Calgary and Edmonton Global.
- Edmonton Global has recently received and investment invitation from a software industry service provider in which they are looking for the right opportunity to expand their North American operations with a "Quality Assurance Facility". In the interest of transparency, this inquiry was distributed to all Edmonton Global Shareholders, with the understanding this may not be a fit for everyone. Edmonton Global shareholders are encouraged to self-select on this opportunity and decide if it is in their best interests to participate or decline. This company currently has operations in various locations throughout Asia and Europe along with facilities in Seattle and Montreal but has no operations in Western Canada. Information provided by each shareholder will be incorporated into a case for the Edmonton Region, in turn the Regional case will be included in the case presented by the Province.
- A highly qualified lead for a company will be in the Metro region looking to view physical locations on April 9 and 10 for specific facility requirements in the manufacturing industry. Shareholders are to submit information if there is a location that fits these criteria in their community. Main requirement on the list was an existing building of 30,000 sq. ft or two existing buildings of 10,000 + 15,000 sq. ft.

Administration

Medical Professional Recruitment

MAP- 2019

The Morniville Detachment's Cpl. Sheldon ROBB has reached out to administration to get direction on what the enhanced policing should look like for 2019. Also, as requested moving traffic violations will be a large part of the enhanced policing plan.

March 15, 2019	Attended ACRWC board Meeting. The audit results were reviewed, and everything is in order however, 2018 budget was 10 million dollars over budget due to a number of emergency repairs to existing infrastructure, pump failures and line flushing etc. The shortfall will be made up in 2019 to re-establish reserves to the comfort zone of 10% of cash assets from the present 3% by decreasing the planned expenditures to 14.8 million dollars from 20 million dollars.
