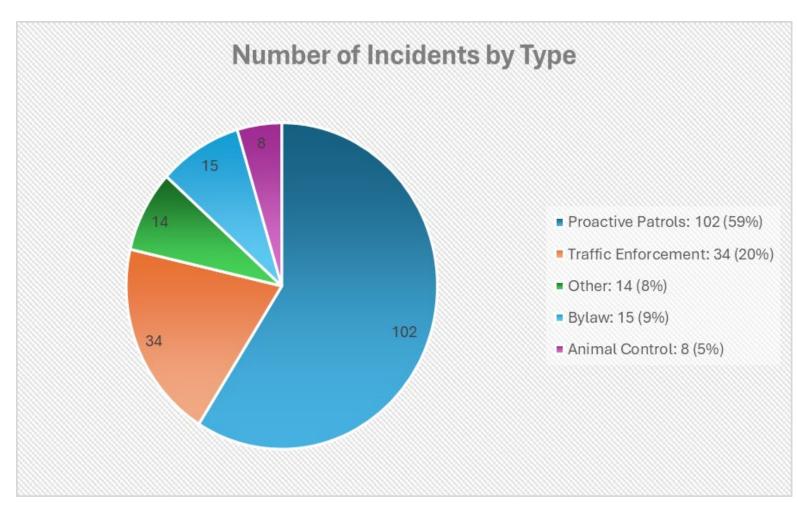

Equitable Police Funding Model

Agenda Item No. 6.1

BACKGROUND/PROPOSAL

Since 2020, municipalities across Alberta have been required to contribute significantly to policing costs through the Police Funding Model (PFM). While intended to increase policing resources in rural and under-served areas, the model has created substantial financial strain for many municipalities, particularly small and mid-sized communities.

Over the past decade, both Alberta Municipalities (ABmunis) and the Rural Municipalities of Alberta (RMA) have adopted numerous resolutions highlighting the need for:

- A more equitable cost-sharing approach.
- Enhanced local input into policing services.
- Greater transparency and accountability regarding how municipal contributions are used.

The Government of Alberta has temporarily frozen municipal police funding contributions for one fiscal year (2024–2025) and extended the current Police Funding Regulation until March 2026. These developments signal a willingness to revisit and potentially revise the funding model

In response, Council made the following resolutions in 2025 related to the police funding model in Alberta:

At the *February 4, 2025 RMC*, Council resolved for administration to draft a resolution for the June 30, 2025 deadline to present at the Alberta Municipalities 2025 Fall Convention AND THAT Council direct administration to draft a letter on behalf of Council opposing the police funding model and send the letter to the Minister of Public Safety and Emergency Services, Mike Ellis; our MLA, Minister Dale Nally; and Alberta Municipalities' Director of Towns East and Vice President of Towns, Trina Jones, requesting their advocacy, as well as our municipal neighbours requesting a letter of support, plus the Minister of Finance, Nate Horner. *Carried Resolution # 25-042*

At the *March 4, 2025, RMC*, Council approved the letter to Minister Ellis regarding the Police Funding Model as presented and directed Mayor Holden to sign the letter on behalf of Council. *Carried Resolution #25-088*

The approved letter was sent in March.

At the *March 15, 2025, RMC*, Councillor Trina Jones and Rachel de Vos of Alberta Municipalities presented information regarding the police funding model and drafting resolutions for the Alberta Municipalities Fall Convention.

The draft resolution, *Resolution for a Reduced and Equitable Police Funding Model* (attached) was presented to Council at the April 23, 2025, Committee of the Whole meeting.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES

The proposed resolution responds to growing concerns over the sustainability and fairness of the current model. It also aligns with previous advocacy from Alberta Municipalities and RMA, emphasizing:

- A reduction in municipal contributions to more sustainable levels.
- Direct correlation between funding and service delivery.
- Local government participation in policing decisions and performance oversight.
- Transparent, itemized reporting of PFM-related costs.

The proposed resolution encourages collaboration between Alberta Municipalities, RMA, and the Government of Alberta to redesign a funding model that is equitable and responsive to the diverse needs of Alberta's communities. This will meet the objective of advocating for all municipalities in Alberta.

Next Steps:

- 1. Submit the resolution to Alberta Municipalities prior to the annual convention deadline following approval by Council at the next Council Meeting.
- 2. Share the resolution with neighboring municipalities and regional partners to encourage support. The Town will need one municipality to second the resolution at the convention and this municipality should represent a different population category.
- 3. Monitor provincial discussions related to the Police Funding Model and participate in consultations when available.

DRAFT RESOLUTION:

The proposed resolution below is intended to advocate for reduced police funding contributions from municipalities, while respecting past advocacy efforts and focusing on transparency, equity, and service accountability:

Title: Resolution for a Reduced and Equitable Police Funding Model for Municipalities

WHEREAS Alberta municipalities are currently required to contribute a growing portion of police funding under the Provincial Police Funding Model (PFM), which has placed an increasing financial burden on municipalities, many of which already face budgetary constraints;

WHEREAS past resolutions from both Alberta Municipalities and the Rural Municipalities of Alberta (RMA) have consistently called for improvements to the PFM, including enhanced equity, transparency, and a clear link between municipal contributions and policing service levels;

WHEREAS the current funding model does not represent improved service outcomes resulting from increased municipal contributions; and (Discussion point: i.e.: more police officers to serve the community relative to funding received)

WHEREAS the Government of Alberta has temporarily frozen municipal policing costs for one fiscal year and extended the Police Funding Regulation through March 2026, demonstrating a willingness to revisit the model and engage with stakeholders.

THEREFORE, BE IT RESOLVED THAT Alberta Municipalities advocate to the Government of Alberta to:

- Reduce municipal police funding contributions under the Provincial Police Funding Model to levels more in line with historical cost-sharing prior to the 2020 changes.
- 2. **Reform the PFM** to ensure that all future municipal contributions are:
 - Equitably assessed based on community size, policing needs, and fiscal capacity;
 - Linked to measurable improvements in policing service levels.
 - o Transparent and itemized in municipal requisitions and budgets.
- 3. Recognize and respect all previous advocacy efforts from both Alberta Municipalities and RMA calling for a fair, accountable, and locally responsive police funding framework.

FURTHER BE IT RESOLVED THAT Alberta Municipalities works jointly with RMA and other stakeholders to ensure any future changes to the policing model or funding responsibilities are subject to broad consultation and supported by clear, public costbenefit analysis.

Title: Lilian Schick School Track Fence Proposal

Agenda Item No. 6.2

BACKGROUND/PROPOSAL

During the October 15th, 2024, RCM, Council reviewed the enclosed proposal and cost share for changes to the fencing around the track area at Lilian Schick School. The proposal was intended to address the safety issue for students of dogs at large and dog feces in this area.

At that meeting, Council resolved to direct administration to have further discussions with the school regarding the fencing. *Carried Resolution #24-432.*

Following discussions with the school board, a second proposal (including cost share) has been created by the school board that may be more effective to address the issue.

The new proposal and cost share is enclosed.

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES

The Town and Sturgeon Public Schools jointly own the track area.

As per the current Joint Use Agreement with the Town, the school board is responsible for maintenance of the track and ball diamond facility in that location.

The Town is responsible for enforcing its Animal Control Bylaw. Despite increased enforcement patrols in this area, as possible within the Town's budget capacity, the issue of dogs at large and feces in this area has continued. Hence, the school board has asked for consideration of a cost share approach to addressing this safety issue for their students via cost share.

During the Sturgeon Region Partnership Committee Meeting held on March 12th, 2025, the following motion was approved by the Committee:

"That the Sturgeon Regional Partnership member municipalities gather feedback from their Councils on the proposal to engage in a grant-funded regional housing needs assessment and report back at the next SRP meeting."

During the April 01st, 2025 Regular Council Meeting, Council resolved to direct administration to bring the topic back to the April 15, 2025 Regular Council Meeting. **Resolution # 25-143**

During the April 15th, 2025 Regular Council Meeting, Council resolved to direct administration to come back with more information about the scope, time and participation needed. **Resolution # 25-169**

DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES

The information requested by Council is below:

Purpose: To provide potential developers with the necessary data about housing needs in the region and secondly to support potential grant applications to address housing needs.

Scope: The proposed housing study is intended to identify gaps in all types of housing needs.

Participation: A letter with a resolution from Council confirming support of the Alberta Community Partnership Grant Application as a partner municipality.

Staff Time: The CAOs from the participating partner organizations would most likely work together on the grant application. It is difficult to estimate the time that would be needed but the application for this grant program is not extensive.

There are 5 municipalities in the Sturgeon region. Two are committed to participating in the project. Bon Accord would be the third municipal partner.

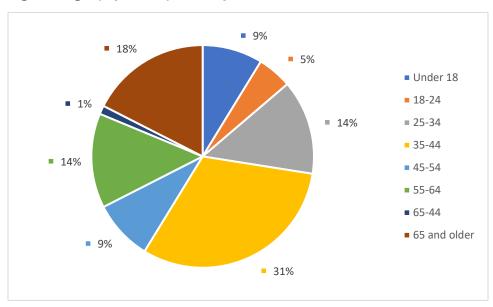
The Proposed Parks Renaming Survey ran from April 1-30, 2025. It was available via paper (hard) copies and online as per the above plan and was open to all ages.

The survey received 86 responses (43 online, 43 paper).

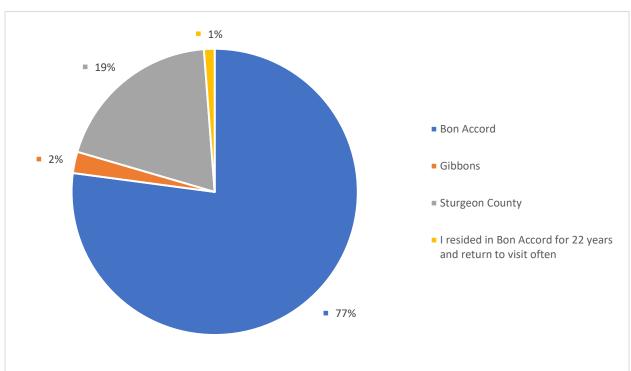

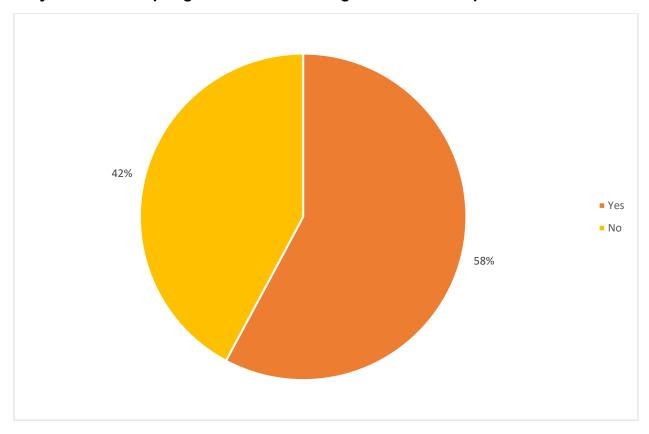
Age Range (Optional) 80 responses



What community do you live in? 83 Responses

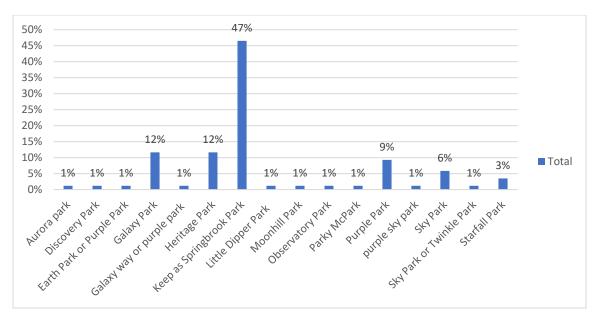


Do you live near Springbrook Park or Roseglen Park? 83 responses



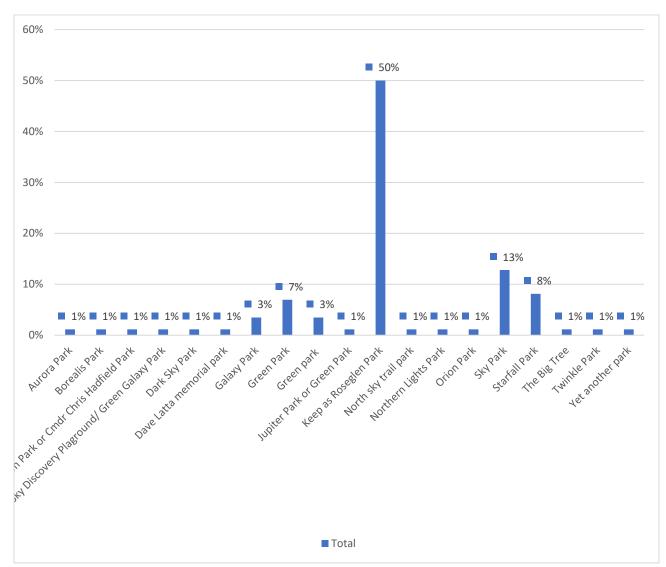
Springbrook Park Naming Options - 43 Responses

Please choose your preferred name for the park located on 52 Avenue between 47 Street & 48 Street.



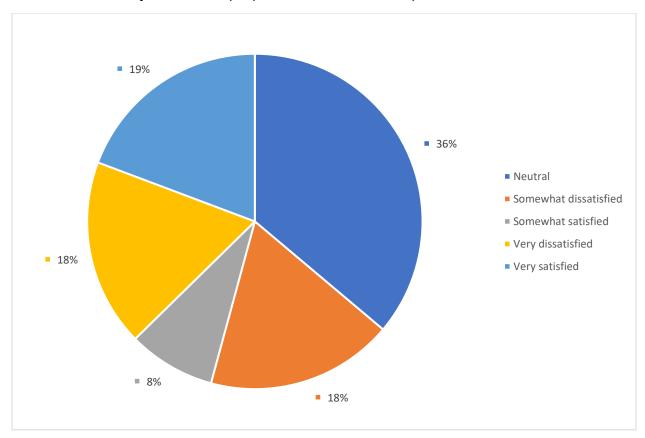

I really don't think constituents are thrilled that this is even being discussed and potential tax dollars being used for this endeavor.

I have no problem with the re-naming to keep in step with our Dark Sky designation. My concern is does this lead to signage? There has been no existing signage for many years on the names that exist for the areanow. Everyone just called them the purple and green park. If actual signage is being considered how would they be paid for? What community input will be there for design, materials etc?

I think the Dark Sky theme names are fun!

Could consider naming a road instead. Galaxy way or another star reference. Maybe the road by LS when it gets paved

This is a joke. Why waste the money

Call the parks with all the kids call the parks by colours and maintain those colours in the future

I think the original names should stay.

I'm genuinely curious about the rationale behind renaming parks that already have well-established names. It seems like a significant investment of time and resources, and I wonder if those efforts might be better directed toward more pressing community needs.

The names need to have something to do with the playground itself. People chose to call the original parks 'purple', 'green' and 'train park' because it made it easier to identify. It will be confusing to have a playground with a spaceship called 'Centennial Park', while the two other parks with no space theme are called something space related. I suggest 'Little Dipper' for Roseglen as the equipment is designed for smaller children so the name ties in that way. As for 'Green Park' perhaps relating it to the Dark Sky Trail as it is the playground most near the trail itself. Alternatively you could name it something like 'Green Galaxy Park' so that again the name ties in with the physical characteristics of the playground.

Unnecessary cost as there is nothing wrong with current names

This is an incredible waste of time and tax payer money. There is currently a half burnt down house that children have access to that should be a priority over naming and signage of parks that people don't call by their respective names anyway.

parks are about the community area they are in. what you haven't provided to us in the survey is why it is important to rename. what will this help in the community? if you name a park after elements in the sky, the park should then have these elements as themes. what is the larger plan this is part of? Help with tourism and community economics? love to understand more to make my feedback of better value to the town.

I have suggested the name "Northern Lights Park" for Roseglen Park. The Northern Lights are readily visible in Bon Accord, especially on winter nights, and our Dark Sky initiatives only makes them more visible. And what better place to view the Northern Lights than in a park within our town.

Springbrook is the community where the park is located, but gets little or no recognition as such. I know there was money to make it into a dark sky site, but that is no longer there. Plus is has the wonderful area Community's in Bloom come to each year to honor those area residents who have left us. Also Mr Latta has done so much for Bon Accord I'm sure something like a park named after him in his honor the family would be greatly appreciated

Paper responses:

"Purple Park is smaller now that is has the new equipment. We suggest making it bigger."

"Just Add Signs so people coming in knows which one is which?!"

"They will still be called Purple Park & Green Park"

"The parks are much smaller now and slightly less functional for younger children. The removal of the train park + installation of the stage is a good example. Park are concentrated oddly for those near the front of town."

"We are ok with not changing the names. If they were to change have checked the alternate name."

"I wish the purple park had more to it and the hill isn't even big enough to slide down like the old hill 25 years ago. Make the hill bigger at that park. If it ain't broke don't fix it."

"Need to have signs up so people know what the names are"

"Do not think the change of names is nessecary."

"don't see a need in changing the names."

"I hope the names do not change. I really want to keep the names of the park."

"Leave as is."

"Leave as is."

"I think some signage would go a long way to clarifying the parks in our town. Long time residents use nomenclature of old and new residents find things confusing - signs will bring us to the same page."

"As long as there is a sign for each"

"All Good."

"For change"

"In regards to the purple park, The new playground as designed for children ages 1-5. My children loved playing on the old one as they can fit on the equipment. The current equipment can't even fit my 6 year old nephew. Please reconsider the entire playground or add more age appropriate equipment as there are many older children in our town."

Summary

Most residents would like to keep Springbrook Park the same name (47%). Heritage Park and Galaxy Park were tied for second place at 12% with Purple Park at 9%.

Most residents would like to keep Roseglen Park the same name (50%). Sky Park was in second place with 13%, followed by Starfall Park with 8%.

There were lots of creative alternative names suggested for both parks, many relating to the Dark Sky theme.

Comment considerations:

- Adding signs to the parks will help new residents understand where these parks are located.
- Concerns about tax dollars and time spent on updating the park names.
- Suggestions for updates to existing parks.

Other Statistics:

- 1 resident of Sturgeon County responded "Yes" that they were close to Springbrook or Roseglen parks, while all other Sturgeon County residents responded "No". 55% of Bon Accord residents responded that "No", they did not live near either of the two parks.
- All but 1 of the respondents who were "Very dissatisfied" with the naming options presented in the survey were not in favour of changing the names of the parks. This 1 respondent did offer alternative naming options.
- Only 2 respondents were from Gibbons.

Dear Mayor Holden:

Thank you for your letter of February 19, 2025, regarding the Police Funding Model (PFM). I appreciate you sharing your concerns.

In response to rising rural crime, the Police Funding Regulation and PFM were introduced in 2020, following collaboration with Alberta Municipalities and Rural Municipalities of Alberta, to create the shared funding model. The model was phased in, with communities contributing to frontline policing costs over a five-year period, starting at 10% and reaching 30% in 2023-24 and 2024-25.

These contributions to date have been based on 2018 provincial police frontline policing costs. Frontline policing costs are based on the costs of the officers delivering frontline policing services and would exclude the costs of specialized police service units such as Serious Crimes Branch, Air Services, and many other specialized units and programs. As a result of the PFM, to date there have been 285 regular members, and 244 civilian member positions created and funded in rural municipalities.

As you are aware, the PFM is in its final year. Looking ahead beyond March 31, 2025, the Police Funding Regulation requires future PFM calculations to be based upon **current** costs of the provincial police service. If this were allowed to occur, as of April 1, 2025, this would have meant small and rural communities would have seen an increase in actual costs of approximately 57%, with no corresponding increase in the services provided.

In order to hold costs stable for municipalities, the province will pay the higher portion of the front-line policing costs for 2025-26. This will allow time for a comprehensive review of the PFM and permit time for the requisite analysis, report, and recommendations to be submitted to government by fall 2025.

The department is now engaging in an independent review of the PFM to determine what changes and improvements may be needed. In accordance with this review, municipalities such as yours will be engaged commencing in spring 2025. More details about the comprehensive review and engagement opportunities for rural municipalities will be released shortly.

The share of front-line policing costs with modifiers for the Town of Bon Accord for 2024-25 will be \$73,176, which is lower than the 2023-24 PFM costs invoiced of \$78,315. During this year of review, Municipalities served by the RCMP under the Provincial Police Service Agreement and subject to the PFM can continue to expect the same level of service without the additional costs for one year.

I appreciate your attention to this important matter. As we work together through this period of review, please be assured that the department remains committed to maintaining effective provincial policing services while ensuring fiscal sustainability for municipalities like Bon Accord. The upcoming independent review will provide a valuable opportunity for your community's voice to be heard in shaping the future of the PFM. I look forward to continued collaboration as we work together to develop a funding framework that best serves the public safety needs of all Albertans.
