Walking Trail Map

Reviewed proposed map and the following trail areas were suggested:

- East side of 51 Street: Extend the sidewalk
- East of 46 Street: Add sidewalk here as well
- Consider vegetation plan, like planting berry bushes along trails
- Connecting trails between parks: Create pathways that link parks to improve overall accessibility
- Stormwater Park Trails: Wait for the final stormwater project plans to integrate trails
- Discuss with engineers adding trails to the 54 Ave project
- Add a sidewalk on 53rd Avenue (north side) and 57th Street to improve access to schools
- To apply for walking trails grants, partner with a non-profit organization

Action Items

- Organize a public survey on park names
- Research the cost and logistics for adding the train equipment, climbing sphere and zipline
- Add on to walking trail map proposed trail on east of 46 street
- Extend sidewalk on East side of 51 Street
- Gazebo at Springbrook, consider running power to it
- Disc golf consideration
- Portable water fountain consideration
- Fruit bushes consideration
